We are looking for contributions to teach a class focused on responsible management and leadership, ethics and / or sustainability. Teaching will be to mixed groups of our students from the following full-time Master's programmes:

We welcome proposals which develop students' understanding of and ability to address some of the most fundamental challenges facing business and society from the perspectives of responsible management and leadership, ethics and sustainability. The topics should be located within the range of the disciplines above. In particular we would welcome proposals which fit the following tracks:

As the schedule overleaf shows we would expect participants to deliver a half-day session (3 hours) which would be repeated at least once depending on demand (that is, with teaching taking place in two or three of the four sessions indicated below). The sessions should follow the NBS teaching style, which is interactive, blending theory and practice.
