









CALL FOR APPLICATION

International Teaching Week in University of Pécs Faculty of Business and Economics

The Faculty of Business and Economics, University of Pécs has the pleasure of inviting you to join its International Teaching Week taking place from 9th to 13th April, 2018.

The main purpose of organizing this event is to provide our students international experience at home, as well as to have the opportunity to get insights, experiences and practices in two hot topics in today's higher education:

1. Flipped Classroom Workshop

The arrival of the young Z-generation and our new e-world bring many changes and also require the reshaping of the teaching techniques in the universities.

The aim of this workshop is to learn from each other, to share the practices and techniques used in the "flipped classroom" and to talk about good (or even bad) experiences of those, who have already applied any part of this technique in a university classroom.

The workshop will begin with a short (20 minutes) introduction of the main ideas, logic and methods behind the flipped classroom. So every participant is welcome, regardless the earlier experiences with this teaching technique. After the presentation an interactive guided discussion will begin, where the thoughts, experiences, ideas, tricks will be negotiated. The conclusions of the workshop will be put together and shared among the participants afterwards.

2. Enhance Your Teaching Through R

R is a free software environment for statistical computing and data visualization. This short workshop consists of three major sessions. First an introduction to R is given followed by two useful toolsets that are currently being used in teaching. Simulations and animations developed using different R packages are the topic of the first set of tools while generating personalized exams and practice exercises using the exams package conclude the workshop. Participation does not require any coding experience or hands-on familiarity with R but they may turn out to be of substantial leverage when customizing these tools to fit your personal teaching materials.
