

**LIST OF NECESSARY DOCUMENTS FOR  
RECOGNITION/VALIDATION OF DIPLOMAS FOR E.U.  
CITIZENS BY CNRED 2020-2021 (applying for a  
Master/Doctorate/DPPD study programme)**

**Registration period for submission of files at W.U.T  
for validation of study diplomas for the academic year  
2021 - 2022:**

**-February - 20th of August 2021** (for admission at a Bachelor+ Master study programme) (prevalently processed);

**-February 2021 - with 30 days before the beginning of the study programme** (for admission at a PhD study programme or at a postuniversity programme of continuous professional development);

**-The deadline for eventual submissions of potential additional documents to the already existing file is of maximum one year from the initial moment of its submission** (it is advisable to submit the documents one month earlier). In case the additional documents are not submitted within this period of time, the original file will not be taken into consideration anymore and a new file will have to be submitted according to the existing legislation.

**A. Required documents / Checking documents for CNRED**

**1. Application form** (to be downloaded from the website of CNRED);

**2. Study document to be recognized:**

-copy, if the study document is issued in Romanian, English, French, Spanish, Italian language;

-copy and certified translation (**in original**) in Romanian language for the documents issued in other languages;

**3. Academic transcripts- in the case of regulated professions and in the situation of the recognition of specialization or when the field of study is not clearly mentioned in the diploma**

-copy, if the study document is issued in Romanian, English, French, Spanish, Italian language

-copy and certified translation (**in original**) in Romanian language for the documents issued in other languages

**4. Other documents, if it is necessary**

\* **Example: Certificate of Authenticity from the Ministry of Education of Moldova** for the diplomas obtained in the Republic of Moldova before 2008

**In order to practice regulated professions in Romania** (medicine, dentistry, pharmacy, general medical assistant, midwife, veterinary medicine, architecture): syllabus of courses/full description of courses, postgraduate diplomas- copy, if the document is issued in English/French/Spanish/Italian or copy and authorized translation into Romanian language if it is issued in other languages

\***Example: Foreign citizens, family members of Romanian citizens, holders of a temporary residence permit**, must submit the proof either of an employment contract or of registration as unemployed person in order to benefit, under the law, of equal treatment with Romanian citizens regarding the study enrollment (OUG no. 194/2002

on the Regime of Aliens in Romania, republished, art. 80 paragraph (3), lit. B) and c))

**5. Identification paper - copy**

-passport / identity card;

-proof of legal name change, if applicable, copy for documents in Romanian language / English / French / Spanish / Italian, and certified translation in Romanian for other languages\;

**6. Proof of payment for evaluation fee - 100 de lei - copy**

The fees can be paid **in lei** at the CNRED Cashier's Office (Monday to Thursday, between 9:00-12:00 and 13:00-15:00) or Payment Order / Postage Mandate / Banking transfer indicating the account below:

#### **Authentication of study documents**

##### **1. Diplomas from Moldova do not need any form of authentication.**

Diplomas issued before 2008 (and diplomas issued after 2008 which cannot be [verified on line](#)) shall be accompanied by a [Certificate of Authenticity from](#)

[the Ministry of Education of Moldova](#) which shall be submitted in original;

**2. [Hague Apostille](#)** is requested for diplomas from [countries which are parties to the Hague Apostille](#) , issued by the [competent authorities](#) in the issuing countries. Hague Apostille Convention is requested for diplomas from Italy, Greece, Spain, Portugal and Cyprus;

**3. Diplomas issued in countries which are not parties to the Hague Apostille shall be authenticated or accompanied by an authentication certificate from by the competent authorities in the issuing countries:**

**-Legalization/Authentication is done by the Ministry of Foreign Affairs** from the issuing country and the Embassy/Consular Office of Romania in the issuing country or by the Ministry of Foreign Affairs in the issuing country and the issuing country's Embassy/Consular Office in Romania; for countries where Romania does not have a diplomatic mission or countries which do not have diplomatic missions in Romania, the study documents shall be legalized by the Ministry of Education and the Ministry of Foreign Affairs from the issuing country

**-Legalization/Authentication exemption is allowed under the law of an international treaty to which Romania is party or on a reciprocity basis.**

#### **ATTENTION!**

The certificate of recognition of preuniversity studies, for undergraduate study programme application, is issued by the Romanian National Centre for the Recognition and Validation of

Diplomas (C.N.R.E.D.), directly to the candidate or the university representative, in person. The diploma of preuniversity studies must be presented, in original, for verification, bearing the Hague Apostille or the specific legalization if the case.

**In case the Certificate of Recognition for admission at Bachelor studies at W.U.T. cannot be taken in original** from the Department of International Relations by its rightful possessor, it can be taken by an intermediate person only on the basis of a Power of Attorney issued in Romanian or in a widely spread international language.  
**!When coming for enrollment, the candidates will present their study documents at the faculty that they have decided to apply for, in original, along with the necessary translations in Romanian (if the case).**
